

Meeting Minutes Wednesday October 26, 2005 Larson Middle School

President Joe Hass gives the greeting:

Attendance: 37 members were in attendance while 2 Guests were in attendance. Don Reinholm and Ross

Guest Speaker: Dave Brown - AMA President

Dave thanked us for inviting him. Dave encouraged us to come see the museum in the AMA headquarters and also mentioned that the national championships are held at the AMA headquarters. The AMA flying site is really something to be enjoyed by all the AMA members. Dave mentioned that he was able to fly a 1970's era Barfly last weekend. He also mentioned the recent helicopter event with nearly 500 helicopter competitors.

Dave spoke about the new the JR spread spectrum radios. The advantage is that there is no need for frequency control. The spread spectrum runs in the 2.4 GHz range, which is much higher than our 72MHz range. Dave believed that this is important because it protects the club's flying sites from radio interference. Dave felt that there was not a large problem from the park fliers. Industry statistics show that the market is selling is 10 park fliers to every one regular RC plane. Dave sees the park flier as a large asset for the RC interest. Currently the FAA has large concerns with the rapidly expanding unmanned aircraft segment. The unmanned group UAV group consists of military and civilian aircraft. The FAA is worried that UAV aircraft are entering FAA airspace. Much of the worry centers around aircraft altitude. The AMA is interested in increasing our ceiling limit of 700 to 1000 ft. Many of the sailplane SIG's would like to see a 3000 ft limit. The FAA deck is 500 ft. Dave is currently tiring to work with the FAA to treat model aircraft as another piece of VFR traffic. Today VFR flight rules have right of way priorities. Dave is proposing that model aircraft would be at the lowest end of the VFR flight priority rules. However, that would give model aircraft the right to be in the airspace regardless of altitude. The AMA currently gets a "NOTEM" from the FAA during the nationals to give the airspace above the AMA property a higher ceiling. The AMA also has difficulties trying to figure out where the model airspace ends and UAV's begins. The bottom line is the FAA is currently determining what the rules are going to be for UAV's. Dave and the rest of the AMA are working to make sure the FAA does not create rules that have unintended consequences for the model aviation community. The current rules say we have a 400 ft ceiling but Dave estimates that 75% of the model flights exceed this limits. Dave stressed the importance not to fly our model aircraft near full sized aircraft. Dave is working with the FAA to get the AMA fields listed on the FAA maps.

The AMA deals with a lot of different issues. One of the AMA's role is to promote model aviation. The AMA also regulates the industry and even insure the industries existence.

Last week the AMA had another fatality. A young adult hit a club gate on a motorcycle. This unfortunate accident will likely affect the AMA from an insurance perspective. Dave said this is the third fatality involving personal motor vehicles on an AMA site., The first two incidents involved chains across roads or entrance points. Other significant injuries were from helicopters. The important information to remember is that safety is important not only when flying our aircraft but also the way we set up our fields.

Dave spoke of the importance of getting kids involved in aero modeling. The experience is good for kids because it's a fun learning experience and it's also good for the AMA. The child that once had a positive experience with model aviation not only helps grow the AMA numbers, there is also much less chance of that child growing into and adult who is a proponent of model aviation.

Dave also told his part in Maynard Hill's model trans Atlantic flight.

Dave spoke about the AMA's field assistance program. A program where clubs can apply for 10% of field improvement projects. 7 or 8 clubs received assistance this year. This year the AMA started a member to member assistance program for modelers who where affected by the hurricanes. This program was a great success. The AMA just instituted a program of disaster relief for clubs. The AMA has about 20k set aside and will solicit donations to help gain revenue.

Guest Speaker: Pete Waters - Frequency committee member:

Pete explained spread spectrum technology. Spread spectrum means that the radio and receiver utilize an entire range of frequencies. The transmitters and receivers have bidirectional communication to utilize the entire spectrum. Pete explained that spread spectrum virtually eliminates radio interference. However, there is a

down side. The down side is that spread spectrum is very directional and airplanes tend to flip around a lot. Spread spectrum controlled airplanes will most likely require multiple antennae BPL is also an issue to the frequency committee.

Show and Tell:

Greg Brausa – Funtana 90 YS 90 flying with 30% heli fuel, 16X4 APC prop with a Dave Brown spinner. The plane weighs about 8.5 lbs. Also a Midwest Aerostar 60 powered by an OS FP 60.

Meeting Minutes Wednesday November 9, 2005 Orion Township Hall

President Joe Hass gives the greeting: Joe displayed some newspaper clippings brought in by Jack Goodrich of the late Bob Irwin's sail boats. Joe introduced John Hoover from Rider's.

The nominations for 2006 Skymasters officers were presented. Nominations were approved and elected. Al McGee is replacing Paul Zabawa while the other officers remain the same.

Attendance: 37 members were in attendance and 4 Guests. Derrick and Dan Van Housen who purchased a Hobbico Superstar and are sharing the plane. Also Art (AMA Hall of Fame) and Arch Adamisin.

Guest Speaker: Pete Bergstrom from Horizon Hobbies.

Pete mentioned that Horizon is trying to grow the model airplane market not just Horizons market share. Pete showed us a new 2.4 GHz spread spectrum radio. This radio is intended to do away with frequency pins. The difficulty with this new technology is the antenna orientation. Horizon is working to overcome this challenge with two receivers and antenna. The transmitter and receiver are bound together and can use any number of different frequencies dynamically. The market for spread spectrum radios is currently being designed for small foam park fliers. In the next year or so Horizon will start marketing to the larger airplane market. Interference from the airplanes is virtually eliminated. The system only requires 3.4 volts in the transmitter but the system Horizon is marketing is set up for 9.6 with a voltage regulator. The reason Horizon is using the old battery size is for old charger compatibility. Pete encourages us to use the current spread spectrum radios for small park fliers until more testing is done with the larger more dangerous planes.

Pete brought along a new Saito 220. Pete said it runs great with a 19X8 prop. Pete brought a tried and true 120 and the new 125 replacement. The 125 was significantly smaller. The 125 was actually 10oz lighter.

Next Pete showed us the Evolution line of gas engines. The entire line can be purchased with electronic ignition. Evolution engines are either 2 stroke conversions or purpose built gas engines. These engines are significantly lighter than Zenoah. Canister mufflers can be purchased. Pete showed us a 26, 58 and a twin 116.

Show and Tell:

Dave Shea – Widgeon 5.5 oz. Dave is enjoying spending large amounts of money to make this small plane lighter.

Paul Borror – SR Eindecker E1 powered by a G26 with the CH ignition. Paul really likes the engineering of the kit.
